

AGREEMENT

between: **MILESTONE PUBLISHING COMPANY LIMITED** (hereafter referred to as MPC Ltd)

and: **BEACH HAVEN BOWLING CLUB** (hereafter referred to as Beach Haven Bowling Club)

MPC Ltd and BEACH HAVEN BOWLING CLUB agree to the following:

1. MPC Ltd will at all times, whilst this contract is in force, uphold the name and image of Beach Haven Bowling Club.
2. MPC Ltd will provide 100 copies of an A6 size programme book for 2020 - 2021 season as requested by The Club.
3. All information (excluding advertising content) that is to be included is to be supplied by Beach Haven Bowling Club, by the specified deadlines, i.e 6 weeks prior to delivery date. Securing copyright clearances for any photographs that are supplied for intended use is the responsibility of Beach Haven Bowling Club.
4. Beach Haven Bowling Club will proof check all copy, with the last proof copy being forward to Beach Haven Bowling Club for final checking. Whilst every effort will be made to ensure there are no errors, any errors printed after Beach Haven Bowling Club has proof checked will be the responsibility of Beach Haven Bowling Club.
5. Advertising Rights & Revenue - MPC Ltd exclusively holds any and all advertising rights in the programme book and is solely entitled to revenue as may be raised from the utilisation of such rights. All such monies are to be paid directly to, and are the responsibility of, MPC Ltd.
6. Sole Rights - MPC Ltd shall have exclusive and sole rights to produce Beach Haven Bowling Club Handbook for the next season, beginning with the 2020 - 2021 season.
7. Sponsors - Beach Haven Bowling Club will allow MPC Ltd to contact all its sponsors and will assist with the supply of the contact names and telephone numbers of same. MPC Ltd will only contact these sponsors with the express purpose of inviting them to advertise in Beach Haven Bowling Club Handbook and will not place them under any pressure to advertise.
8. Acknowledgements - Beach Haven Bowling Club will send a letter of thanks to each advertiser in the handbook if they should wish, giving their assurance that the advertisers will be given preference for business requirements and that members of Beach Haven Bowling Club will be actively encouraged to support those businesses who advertise.
9. Delivery - MPC Ltd will deliver the programme books to Beach Haven Bowling Club and furthermore, delivery will be by Beach Haven Bowling Club specified deadline, i.e. 15TH SEPTEMBER 2020.

10 Costs - MPC Ltd will bear all costs associated with the production and printing of the programme books, including the delivery charges. However should a shortfall occur we would hope after consultation with the club, to look to the club to assist in part to overcome the shortfall.

11 Termination of Agreement - This agreement may be terminated between the parties by:

- a) one party giving notice in writing to the other party, a minimum of 3 months in advance of the above delivery date, i.e. by2020.
- b) delivery of the Programme books being overdue more than 21 days past the agreed delivery date, i.e. later than2020.
